On 26 November 2007 the issued ordinary share capital was consolidated and for every 8 existing ordinary shares of 3 US cents each held at 6 p.m. on 23 November 2007, shareholders received 7 new ordinary shares of 3 3/7 US cents each in their place. Therefore to obtain a true comparison between dividends, the dividend amount per share quoted in dividend 27 onwards should be reduced by one eighth when compared to dividends 25 and 26.

Effective 14 August 2006, each 18 US cents ordinary share was sub-divided into six ordinary shares of 3 US cents each. Therefore the dividend per share amounts quoted in dividends 1 to 24 should be proportionately reduced when comparing any of them with future dividends from dividend 25 onwards. Similar comments apply to comparisons of pre and post sub-division DRIP share prices.
