## Re: Changes and Updates to the Company

We are writing to inform you regarding the changes to the Company. Unless otherwise specified, capitalised terms used in this notice shall have the same meanings as those in the Prospectus of the Company dated 18 March 2025 (the "**Prospectus**").

## 1. Amendment to definition of "business day" in the Bye-laws

We refer to the notice dated 27 January 2025 in relation to the 2025 Annual General Meeting of the Company (the "**Meeting**") (which was adjourned to 17 March 2025), and the proposed resolution to amend the definition of "business day" in Bye-law number 1 of the Company set out therein (the "**Proposed Resolution**").

We wish to advise that the Proposed Resolution was duly passed at the adjourned Meeting held on 17 March 2025 in accordance with Bye-law number 100 of the Company.

## 2. Amendments and updates to the Prospectus

To reflect the corresponding update in the Bye-laws, the definition of "Business Day" in Appendix 1 to the Prospectus has been amended on 18 March 2025 (the "Effective Date") as follows:

'Business Day' means a day (except Saturday and Sunday) on which (i) the Stock Exchange of Hong Kong is open for normal trading and (ii) financial markets are generally open for business in Dublin, London and New York, unless the Directors otherwise determine.

For the avoidance of doubt, the amendments to the definition of "Business Day" in the Prospectus are made for clarification purpose only. There is no actual change in practice as to how Business Days of the Company are determined.

The Prospectus has also been updated on the Effective Date to reflect other miscellaneous updates, including consolidation of previous addenda into the Prospectus.
