Share Class Naming Convention

As noted in the Prospectus, under the naming convention adopted by the Company in respect of the naming of Share Classes (the “Naming Convention”), the letters set out below have the following significance: Not all combinations of share class characteristics as listed in the table below will be available for subscription, for example “L” and “M” share classes are not available in every Portfolio:
